### Important Notes

The Nominated Estimated Pool Return (NEPR) is set at the start of the season, using market rates at that time, in order to establish a rate to pay growers during harvest. The 19/20 NEPRs were based on market rates prevailing on 22nd October 2019.

**NEPRs should not be used as an indication of final pool return.**

Current EPRs will be updated throughout the harvest.

Finance costs are the interest and financing costs associated with CBH Group's funding facility, used to pay growers before payment for sales made in the pool have been received.

New pool grades may be introduced throughout the harvest period where appropriate

### Special Conditions

**Pt Lincoln**-Pool deliveries in Pt Lincoln zone will be subject to a \$10 per tonne discount across all grades.

**Pt Giles**-Pool deliveries in Port Giles zone will be subject to a \$10 per tonne discount across all grades.

**Walleroo**-Pool deliveries in Wallaroo port zone will be subject to a \$15 per tonne discount across all grades.

**Thevenard**- No deliveries currently accepted in Thevenard port zone.
